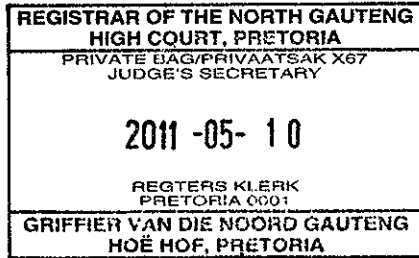

DRAFT ORDER

IT IS ORDERED BY AGREEMENT BETWEEN THE PARTIES THAT:

1. The suspension of the First and the Second Applicant is set aside with immediate effect and the Applicants are reinstated to the Council to attend all Council meetings of the Council and to participate in the business of the Council as full members of the Council.

2. The Applicants undertake to withdraw forthwith their complaint to the Public Protector.

3. The Applicants and the First, Second and Third Respondents all undertake to work together to solve the problems which exists between them and members of the Council and to work together to further the interests of the professions to be served by the Council.

4. The Third Respondent is ordered to pay the costs of the application including the costs of two Counsel.
